प्रारंभिक शिक्षा विभाग, उप-निदेशक, प्रारंभिक शिक्षा मण्डी, जिला मण्डी, हि. प्र. के कार्यालय में अनुबंध के आधार पर शास्त्री अध्यापक (भूतपूर्व सैनिकों के आश्रितों) के 44 पदों को वैच आधार पर भरने हेतु काउंसलिंग प्रक्रिया दिनांक 05 नवंबर, 2024 (मंगलवार) को निर्धारित की गई है। इस काउंसलिंग प्रक्रिया में वही अभ्यर्थी भाग ले सकते हैं जो शास्त्री के भर्ती एवं पदोन्नति नियम, 2012 के तहत तथा राष्ट्रीय अध्यापक शिक्षा परिषद की समय-समय पर जारी अधिसूचनाओं के अनुसार निर्धारित योग्यतापूर्ण करता हो जिनका विवरण निम्न प्रकार से है:-

(a) Essential Qualifications:-

(a) Shastri / Graduation with Sanskrit / Post Graduation in Sanskrit from recognized University with atleast 50% marks either in Shastri or in Graduation or in Post Graduation and Bachelor of Education (B.Ed.) from National Council for Teacher Education recognized institution.

OR

Senior Secondary (or its equivalent) with atleast 50% marks and 4- year Bachelor in Elementary Education(B.El.Ed.) with Sanskrit.

OR

Senior Secondary (or its equivalent) with atleast 50% marks and 4-year B.A./ B.Sc.Ed. with Sanskrit or B.A.Ed. / B.Sc.Ed. with Sanskrit.

OR

Graduation with Sanskrit atleast 50% marks and 1-year B.Ed. (Special Education)

OR

Post-Graduation in Sanskrit with minimum 55% marks or equivalent grade and 3-year integrated B.Ed. / M.Ed.

OR

4-years degree of B.A.Ed. / B.Sc.Ed. with Sanskrit from any National Council for Teacher Education recognized institutions.

AND

b) Pass in Teacher Eligibility Test (TET Shastri) to be conducted by the State Government in accordance with the guidelines framed by the NCTE for the purpose.

Note: -(1) Minimum percentage of marks in Graduation shall not applicable to those incumbents, who had already taken admission to the Bachelor of Education or Bachelor of Elementary Education or Equivalent course prior to the 29th July, 2011.

Note: -(2) A candidate shall be eligible for appointment to Class-III/ Group-C Post(s), if he /she has passed Matriculation and 10+2 from any school / institution situated within Himachal Pradesh: Provided that this condition shall not apply to the Bonafide Himachalis.

Note: -(3) Relaxation up to 5 % will be allowed in minimum educational qualifications and also in minimum qualifying marks for TET to the candidate belonging to SC/ST/OBC/PH categories of Himachal Pradesh.

Note: -(4) Candidate must fulfill all the requisite qualification on the date of publication of advertisement for the recruitment of these posts.

(b) Desirable Qualification

Knowledge of customs, manners and dialects of Himachal Pradesh and Suitability for appointment in the peculiar conditions prevailing in the Pradesh.

Age Criteria

Between 18 to 45 Years.

In case of direct recruitment through batchwise basis, candidates who have crossed the upper age limit of 45 years shall also be considered for appointment in case they have registered their names before attaining the age of 45 Years in employment exchange of HP.

Pay Scale

Fixed amount of Rs. 21360/- (i.e. equal to 60% of first cell of level 9 of the pay matrix of corresponding cadre of employees working on regular basis) as per HPCS(RP) Rules, 2022.

Any Other Information

- For batch wise recruitment the batch will be reckoned from the date of issuance of B.Ed. pass certificate. If more than one candidate has been issued the final examination certificate on the same date then the inter-seniority would be determined on the basis of marks obtained in TET (Shastri) and if there is still case of tie in that event senior in age would get precedence over junior in age.
- Those who are not willing to serve in the schools in interior and tribal areas of Himachal Pradesh need not come for counseling.
- The candidates will have to bring with them only the relevant degree/diploma in original with self attested copies thereof for the post and also latest certificates regarding their claim for consideration under any of the reserve categories of H.P.

अतः जो भी पात्र अभ्यर्थी उक्त काउंसलिंग प्रक्रिया में भाग लेना चाहता है वह निर्धारित दिनांक 05 नवंबर, 2024 (मंगलवार) को सुबह 11 बजे उपनिदेशक प्रारंभिक शिक्षा के कार्यालय मण्डी में आकर आवेदन कर सकता है। माननीय न्यायालय द्वारा दिए गए दिशा-निर्देशों के अनुसार अन्य जिलों के प्राथी जिनका नाम संबंधित रोजगार कार्यालय में दर्ज है वह भी उक्त काउंसलिंग प्रक्रिया में भाग ले सकते हैं। अभ्यर्थी अपने एक पासपोर्ट आकार के फोटो, आवश्यक दस्तावेजों (नवीनतम चरित्र प्रमाणपत्र, हिमाचली ब्योनाफाइड, श्रेणी प्रमाणपत्र और लाइव रोजगार कार्ड) और शैक्षणिक व व्यवसायिक योग्यता से संबंधित दस्तावेजों सहित निर्धारित तिथि को उपनिदेशक, प्रारंभिक शिक्षा मण्डी जिला मण्डी, हि.प्र. के कार्यालय में उपस्थित हों। आवेदन प्रपत्र अर्थात् प्राथी का बायोडेटा फार्म उक्त तिथि को कार्यालय में भी उपलब्ध होगा। अन्य जानकारी के लिए दूरभाष नम्बर 01905-223454 पर किसी भी कार्य दिवस में संपर्क किया जा सकता है।

3. Category certificate (Non-SC/ST/OBC certificate in case of General BPL) (Gen EWS) (SC/ ST/ OBC/BPL in case of reserved categories) (WFF). BPL certificate must be countersigned by the BDO concerned.
4. Himachal Bonafide.
5. Character certificate within the period of validity.
6. All academic qualification certificates in chronological order (Matric/ 10+2/ Shastri /Graduation/ Post graduation certificate) etc.
7. Professional qualification certificate (B.Ed./ B. El. Ed./ 4 year B.A.Ed./B.Sc.Ed/ 3-year integrated B. Ed./M. Ed.)
8. Teacher Eligibility Test (TET)(Shastri), to be conducted by an authority designated by the H.P. State Government.
9. **Ward of Ex-Servicemen Certificate:-** It is certified that Sh./ Smt./ Kumari Date of Birth, who has been married with Shri S/o Sh. R/o Village P.O. Tehsil District State on (as per the certificate produced by the applicant from the concerned Gram Panchayat Authority) is a daughter of No. Rank Name R/o of Village P.O. Tehsil District (HP) as per records held in discharge certificate of the above-named ex-servicemen. **Should be issued by the Deputy Director, Zila Sainik Welfare Office (Sign & Seal).**
10. **Annexure- 'A' : Form of certificate to be furnished by the sons/daughters or wives of ex-servicemen to be considered against the posts reserved for ex-servicemen:-** It is certified that Sh./ Kumari/Smt. resident of Village P.O. Tehsil District (Himachal Pradesh) is the dependent son / daughter or wife of Shri. Ex. Servicemen No. Rank, who has not been rehabilitated through employment against the post reserved for ex-servicemen with the H.P. Govt./ Corporation / Board/ Autonomous Body of H.P. as well as Central and other State/ Union Territory Government or Public Sector Undertaking/ Autonomous Body/ Banks, etc. under the control of the said Central or other State/ Union Territory Government. **Should be issued by Patwari/ Pradhan of Gram Panchayat/ President of Municipal Committee or Notified Area Committee/ Executive Officer of the Municipal Corporation of the area and counter signed by Tehsildar/ Sub-Divisional Officer (Civil) of the area.**
11. **Annexure- 'B' in the form of Affidavit:-** I Son/ daughter/ wife of Sh. Ex. Servicemen No. Rank Resident of Village P.O. Tehsil District (Himachal Pradesh) do hereby solemnly declare and affirm that no other ward (i.e. son/ daughter or wife) of my father/ husband has been provided employment against the vacancies reserved for the Ex-Servicemen under the H.P. Govt. / Corporation/ Board/ Autonomous Body of H.P. as well as Central and other State/ Union Territory Government or Public Sector Undertaking/ Autonomous Body/ Banks, etc. Under the control of the said Central or other State/ Union Territory Government. **Should be verified / countersigned by the Tehsildar/ Sub-Divisional Officer (Civil) of the area.**
